Dear Mr. Burack,

Per Docket Number 2008-04 regarding Granite Reliable Power, LLC, I respectfully motion to you to allow me to intervene on behalf of the citizens of Millsfield, New Hampshire. Millsfield is one of the primary sites for the proposed Wind Farm proposed by Granite Reliable Power.

I am a selectman of the unincorporated Place known as Millsfield, and the citizens of Millsfield are very concerned about the following matters:

- The lack of direct communication to the citizens of Millsfield for this project. Apparently the only communication has been to the State of New Hampshire and to the County. This wind farm is proposed to be mostly situated in Millsfield and the citizens of Millsfield ought to be directly involved in matters pertaining to their own interests.
- Tax deals are being struck, plans are being evaluated, public hearings are being apparently scheduled, **but no one is communicating the details of those plans, deals, or even notifying us of those public hearings.**
 - A resident, who does not live in Millsfield, is the one who sent me notification of the order of the Site Evaluation Committee dated August 27th. The idea of excluding the citizens of Millsfield from all official communications from any State agency regarding any hearings about this project is unconscionable.
- The Citizens of Millsfield want to totally stop this wind farm project unless we are involved in every aspect of this proposed wind farm.


