

TOWN OF GROTON'S PETITION TO INTERVENE

NOW COMES the Town of Groton, by and through its attorneys, Mitchell Municipal Group, P.A., and in petitioning the Site Evaluation Committee ("the Committee") to allow it to intervene in the above captioned matter states as follows:

1. On March 26, 2010 Groton Wind, LLC filed an Application for a Certificate of Site and Facility for the siting, construction and operation of a wind farm consisting of 24 wind turbines to be located in the Town of Groton.

2. Pursuant to RSA 541-A:32 and Site 202.11, the Town of Groton petitions the Committee to permit it to intervene in this matter.

3. Given the proposed location of 24 wind turbines in the Town of Groton, the rights, duties, privileges, immunities and other substantial interests of the town and its residents may be affected by the present proceeding.

4. The interests of justice and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.

A. Allow it to intervene in the above captioned matter; and

B. Grant such other and further relief as the Committee deems just and

necessary.
