MOTION FOR ENLARGEMENT OF TIME TO PUBLISH
ORDER AND NOTICE OF PUBLIC MEETING
AND DISPLAY AD

NOW COMES Groton Wind, LLC (“Groton Wind”) and respectfully moves that the New Hampshire Site Evaluation Committee (“the Committee”) extend the deadline by which Groton Wind must publish the Committee’s Order and Notice of Public Meeting (“Order and Notice”) dated January 18, 2013 and a display ad in a newspaper of general circulation in Grafton County. In support of this Motion, Groton Wind states as follows:

1. In its Order and Notice dated January 18, 2013, the Committee, *inter alia*, directed Groton Wind to publish said Order and Notice, along with a display ad containing certain information about the Committee’s public meeting to be held February 19, 2013. In addition to publication in the New Hampshire Union Leader or New Hampshire Sunday News, the Order and Notice directed Groton Wind to make publication in a newspaper of general circulation in Grafton County on or before January 29, 2013.
2. The undersigned received said Order and Notice via electronic mail from the Committee’s Assistant, Ms. Murray, on January 22, 2013. On that day, the undersigned investigated the submission deadlines for publication in the Plymouth Record Enterprise,

a weekly newspaper in which prior publications concerning the Groton Wind docket have been made. Upon such investigation it was learned that the deadline for publication in the January 24th edition of the newspaper had passed, and that the next publication date is January 31st.

3. On January 22, 2013, the undersigned informed the Committee's Counsel, Michael Iacopino, of the fact that it would not be possible to publish the Order and Notice and display ad by January 29, 2013 in the Plymouth Record Enterprise, and was advised by Attorney Iacopino to make the publication on January 31, 2013 and to file the within motion.

4. Because the January 31, 2013 publication in the Plymouth Record Enterprise will occur two and one-half weeks before the Committee's February 19, 2013 meeting, the public will be provided sufficient notice of the meeting. In addition, because Ms. Murray e-mailed a copy of the Order and Notice to the Service List in this docket, interested parties are already aware of said meeting. In these circumstances, neither a party nor any member of the public will be prejudiced by the requested two day publication extension.

5. In accordance with SEC Rule Site 202.14 (d), the undersigned has made a good faith effort to obtain concurrence with the relief sought from the parties to this docket. As of the time of the filing of this motion, the following parties have indicated their positions on it: The Town of Groton concurs; Assistant Attorney General Evan Mulholland takes no position; and the Mazur-Wetterer intervenor group abstains.


WHEREFORE, Groton Wind respectfully requests that the Committee:


