Dear Ms. Murray:

Pursuant to Chairman Burack's Procedural Order and Notice of Possible Suspension of Certificate issued November 4, 2013, Groton Wind, LLC ("Groton Wind") files this response to the State Fire Marshal's October 18, 2013 filing.

Groton Wind believes it has filed all of the drawings and other documentation requested by Investigator Anstey of the State Fire Marshal's Office and has initiated discussions with Investigator Anstey in an effort to resolve issues of concern to that office. Although Groton Wind has attempted to formalize an agreement with Investigator Anstey and his former attorney, Senior Assistant Attorney General Karen Schlitzer, no definitive settlement has been reached as of this time. On Friday of last week, the parties to this docket received notice that Senior Assistant Attorney General Schlitzer has withdrawn as counsel for the Department of Safety (the agency within which Investigator Anstey's Office is located) and that Attorney Dianne Martin is now representing that agency. Groton Wind has contacted Attorney Martin in an effort to pursue settlement negotiations, and is hopeful that it can work with the State Fire Marshal's Office to resolve that office's issues.

In view of the foregoing, and in the spirit of cooperation, Groton Wind does not believe that it would be constructive to argue about or otherwise litigate at this juncture the issue of whether the Site Evaluation Committee may properly rely upon the codes cited in Investigator Anstey's October 18, 2013 filing. Notwithstanding this position, in order to preserve its rights, Groton Wind objects to the Committee's reliance on the codes set forth in the Fire Marshal's October 18, 2013 letter and expressly reserves its right to supplement this general objection with more specific objections at a later date (if necessary).


