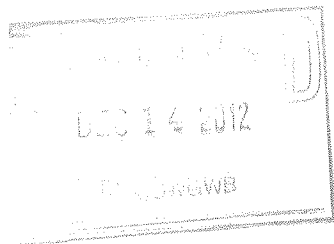

**CITY OF BERLIN'S STATEMENT OF SUPPORT OF MOTION
OF BERLIN STATION, LLC FOR AMENDMENT OF THE

NOW COMES the City of Berlin, ("**the City**") to state its support of the Motion of Berlin Station, LLC ("**Berlin Station**") for Amendment of the Certificate of Site and Facility. On November 6, 2012, Berlin Station filed a Motion for Amendment of the Certificate of Site and Facility ("**Motion to Amend**"). The proposed amendments to the Certificate of Site and Facility ("**Certificate**") include requests to reconfigure the wood yard; eliminate the proposed river walk; reduce the fencing requirements; and modify the landscaping plan as originally proposed. This Statement is authorized by the vote of the City Council on November 5, 2012.


