

MOTION TO INTERVENE *PRO SE* OF MARK J. AND BRENDA SCHAEFER

Pursuant to the New Hampshire Site Evaluation Committee Rules Site 202.11, Mark J. and Brenda Schaefer hereby move for permission to intervene *pro se* in the above-referenced proceeding. In support of their Motion to Intervene, Mark J. and Brenda Schaefer offer the following arguments:

- (1.) Mark J. and Brenda Schaefer can demonstrate a substantial interest which may be affected by the outcome of the proceeding.**

Our residence is on property which directly abuts the land which Antrim Wind Energy, LLC has leased for their proposed wind facility. As 27 year residents of Salmon Brook Road in Antrim, we are concerned about the potential disruption of this peaceful, rural area and have grave reservations about the effects an industrial wind facility and its noise will have on our health and on the quality of wildlife habitat for the region.

- (2.) The interest of Mark J. and Brenda Schaefer will not be adequately protected by other parties.**


In exercising its discretion, we respectfully ask that the Committee consider whether the party's interest will be adequately protected by other parties. Since we, as residents of the North Branch region of Antrim where the proposed wind facility would be constructed, do not feel that our interests and concerns have been addressed thus far in proceedings by the Selectmen and Planning Board of Antrim, we do not believe that any other party to this proceeding can adequately represent our interests in proceedings before the Committee.

- (3.) The intervention of Mark J. and Brenda Schaefer will be in the interest of justice and will not impair the orderly and prompt conduct of the proceedings by allowing the intervention.**

Pursuant to the SEC Order of March 21, 2011, Mark J. and Brenda Schaefer file this Motion to Intervene by the deadline set forth by the Committee for Docket 2011-02 and request that we be permitted to intervene with full standing to participate in all phases and activities of the proceeding. We respect the importance of conducting this proceeding in an orderly manner that will not unduly delay the Committee or the parties in reaching an outcome. We are prepared to work closely with other parties to the proceeding in the interest of maintaining order and respectfully offer that our participation, if permitted, would be in the interest of justice.
