PETITION OF THE HOUSE OF REPRESENTATIVES, SCIENCE TECHNOLOGY AND ENERGY COMMITTEE, TO ADOPT RULES ESTABLISHING PROCEDURES AND SITING CRITERIA FOR WIND POWERED FACILITIES

Background

On March 8, 2013, the Committee received a petition from the House of Representatives, Science Technology and Energy Committee, Pursuant to RSA 541-A: 4 (Petition). The Petition requests that the Committee "adopt rules establishing comprehensive procedures and siting criteria for applications for certificates for wind-powered energy facilities." The Petition also suggests that the Committee utilize the document entitled "Wind Energy Facility Siting Guidelines Working Group - Proposed Wind Power Siting Guidelines - May 29, 2007 Forwarded to the NH Energy Policy Committee Wind Siting Subcommittee" (Wind Guidelines) as a starting point for the requested rulemaking proceeding.

the Committee will hear public comment and determine whether to grant or to deny the Petition. If the Petition is denied, a written order will follow. If the Petition is granted the Committee will commence a rulemaking proceeding pursuant to RSA 541-A: 3 and request a fiscal impact statement pursuant to RSA 541-A: 5.
