MOTION OF COUNSEL FOR THE PUBLIC TO COMPEL PAYMENT OF FEES

Counsel for the Public, by his attorneys, the Office of the Attorney General, hereby moves the Committee for entry of an order compelling Granite Reliable Power, LLC to pay the fees of Dr. C. William Kilpatrick in the amount of \$15,000, and to require it to pay Counsel for the Public's reasonable attorneys fees associated with bringing this motion. The reason for the relief requested is that Dr. Kilpatrick's budgeted fees were already approved by the Committee and GRP has refused to pay them. In support hereof, Counsel for the Public respectfully represents as follows:

- 1. On June 18, 2014, Counsel for the Public moved the Committee pursuant to RSA 162-H:10, V, for leave to hire Dr. C. William Kilpatrick and to have GRP bear the fees and costs in the amount of \$15,000.
- 2. GRP did not object to the Motion to retain Dr. Kilpatrick or the request that GRP be required to pay his fees and costs.
- 3. On July 7, 2014, the Committee entered its Order On Motion To Retain Consultant (the "Order") granting Counsel for the Public's motion and ordering:

The motion of Counsel for the Public to retain Dr. C. William Kilpatrick is granted and the Applicant shall pay for the services of Dr. Kilpatrick, as invoiced, in an amount not to exceed \$15,000.

- 4. On January 2, 2015, Counsel for the Public forwarded Dr. Kilpatrick's invoice for his fees and costs to Attorney Pachios and requested payment. A copy of the invoice is attached hereto as Exhibit "A". Counsel for the Public followed up with emails to Attorney Pachios on January 20, 2015, and again on February 12, 2015 (also to Attorney Warner). To date Attorney Pachios has not responded to any of the emails and GRP has not paid the fees to Dr. Kilpatrick.
- 5. Counsel for the Public seeks his attorneys fees in the amount of \$500 being an estimate of the time required to follow up with Attorney Pachios, and Dr. Kilpatrick and to file and prosecute this motion. Such is necessary owing to GRP's unexplained and extraordinary refusal to comply with the Order and timely pay Dr. Kilpatrick's fees.

WHEREFORE, Counsel for the Public respectfully requests that the Committee enter an order requiring payment of the fees as invoiced in the amount of \$15,000 and requiring payment of Counsel for the Public's attorney's fees in the amount of \$500, and granting such other and further relief as may be just.
