## **RE:** Draft Site Evaluation Committee Rules

Dear Mr. Wiesner:

The New England Clean Energy Council (NECEC) would like to indicate its support for the *Draft Site Evaluation Committee Rules* (*Draft Rules*) submitted by Cate Street Capital, EDP Renewables North America, Eolian Renewable Energy, Iberdrola Renewables, National Grid, Northeast Utilities and Public Service of New Hampshire on September 22, 2014. (See attached.) The *Draft Rules* were developed in response to the Site Evaluation Committee request for advance public comment on the rulemaking required by recently enacted legislation (Senate Bill 234 and House Bill 1602, as well as Senate Bill 99 of 2014. We recognize that we are submitting our letter past the advance comment deadline but hope that it will be helpful to you in your consideration.

NECEC is a clean energy business and policy organization. The NECEC mission is to accelerate New England's clean energy economy to global leadership by building an active community of stakeholders and a world-class cluster of clean energy companies. NECEC is the only organization in New England that covers all of the clean energy market segments, representing the business perspectives of investors and clean energy companies across every stage of development.
