PETITION FOR INTERVENTION
BY ANTRIM PLANNING BOARD

NOW COMES the Petitioner, Planning Board of the Town of Antrim, New Hampshire (“Antrim PB”), by its undersigned chair, and respectfully petitions the New Hampshire Site Evaluation Committee (“the SEC” or “the Committee”) to grant it leave to intervene in these proceedings pursuant to NH Code of Administrative Rules, Site 202.11 and RSA 541-A:32. In support of its petition, ANTRIM PB states as follows:

1 Antrim PB is an elected Planning Board as authorized under NH RSA 673:1. The Antrim PB includes six members elected by the voters and a seventh member who shall be a member of the Board of Selectmen, appointed by the Selectmen.

2 As the elected statutory body having principal responsibility for creation and implementation of land use planning regulations in Antrim, the Antrim PB has direct interest in this project. Further, the Antrim PB was an intervenor in Docket 2011-02 where AWE petitioned the SEC to take jurisdiction of the project. Finally, the meteorological tower proposed (and subsequently built) by AWE in anticipation of a proposal for a wind energy project, was before town boards in 2009 and 2010.

3 For the foregoing reasons, Antrim PB ask leave to intervene pursuant to Site 202.11(b) on the following grounds:

- a. This Petition will be served and submitted within the time limits set out in the rule;

- b. This Petition states facts demonstrating that Antrim PB has substantial interests which might be affected by the proceeding; and
- c. That granting this Petition would serve the interest of justice.

Request for Relief

WHEREFORE, Antrim PB respectfully requests that the SEC issue an order granting its petition for intervention and granting such other and further relief as it deems appropriate.
