RE: Evidence of ILOC Renewal

Dear Chairman Edwards and Members of the Board,

Section 14.2.1 of the Amended Agreement between the Town of Antrim New Hampshire and Antrim Wind Energy LLC states, "Forty-five days prior to the extension of the ILOC Owner shall provide documentation to the Town demonstrating that the extension complies with the decommissioning requirements of the Agreement and the SEC Certificate for the following annual Period."

There has been no change to the decommissioning requirements in the Agreement or SEC Certificate, or in the decommissioning cost estimate to complete those obligations for the next annual period.

The ILOC issued by the New York Branch of the Canadian Imperial Bank of Commerce (CIBC) states in Additional Terms and Conditions #1, "This letter of credit is effective from February 8, 2018 (date of issue) and shall expire on February 1, 2019 at our counters, provided that this letter of credit shall be deemed to be automatically extended without amendment for one (1) year of the current expiry date hereof, or any future expiry date, unless at least sixty (60) days prior to the expiry date we notify you by registered mail or courier (with delivery confirmed in writing) return receipt requested that we elect not to consider this letter of credit extended for any such additional period."

As of the date of this letter it is less than 60 days until the current date of expiry and CIBC has not provided notice to the Town that they elected not to extend the ILOC for an additional one-year period. Therefore, by its terms the letter of credit is deemed extended without amendment. This letter, together with a copy of the ILOC attached, shall serve as timely documentation of the same as required by the Agreement and SEC Certificate.

- 1. This letter of credit is effective from February 8, 2018 (date of issue) and shall expire on February 1, 2019 at our counters, provided that this letter of credit shall be deemed to be automatically extended without amendment for one (1) year from the current expiry date hereof, or any future expiry date, unless at least sixty (60) days prior to the expiry date we notify you by registered mail or courier (with delivery confirmed in writing) return receipt requested that we elect not to consider this letter of credit extended for any such additional period. Upon receipt by you of such notice and if a substitute letter of credit in form, substance and amount acceptable to you is not provided to you by or on behalf of the applicant at least thirty (30) days prior to the then current expiry date in effect at the time of notice, then you may draw under this letter of credit up to the available amount.
- 2. The amount available to be drawn hereunder at any time ("available amount") shall be equal to the original amount less the aggregate amount of any prior paid drawings hereunder at our counters.
- 3. Any number of partial drawings is permitted from time to time under this letter of credit.
- 4. A failure to make any partial drawings at any time shall not impair or reduce the availability of this letter of credit in any subsequent period or our obligation to honor your subsequent demands for payment made in accordance with the terms and conditions of this letter of credit.

If a drawing is made by you hereunder at or before 11:00 a.m., New York time, on a business day (as hereinafter defined) in conformance with the terms and conditions of this letter of credit, payment shall be made to you in immediately available funds on the next following business day. if a drawing is made by you hereunder after 11:00 a.m., New York time, on a business day in conformance with the terms and conditions of this letter of credit, payment shall be made to you in immediately available funds on the second business day thereafter.
- 9. The term "business day" as used herein means any day other than (i) a Saturday, or (ii) a Sunday, or (iii) a day on which banking institutions located in the City of New York, New York are required or authorized by law to be closed.
- 10. This letter of credit may be terminated upon issuer's receipt of a written release from the beneficiary releasing the issuer from its obligations under this letter of credit along with the original of this letter of credit
- 11. Applicant's filing of a bankruptcy, receivership or other debtor-relief petition, and/or applicant's discharge thereunder, shall in no way affect the liability of the issuer under this letter of credit and, as a result, the issuer shall always remain liable to the beneficiary for the full amount of this letter of credit, notwithstanding said bankruptcy, receivership, petition or discharge not to exceed the available amount of this letter of credit.
