Re: Antrim Wind Energy – Service Maintenance Agreement Amendment Notice

Dear Ms. Pamela G. Monroe,

This revised letter is to provide the State of New Hampshire Site Evaluation Committee an update concerning Antrim Wind Energy Service Maintenance Agreement (SMA) scope change, required as per a condition stated in Application of Antrim Wind Energy LCC for a Certificate of Site and Facility, Docket No. 2015-02, dated March 17, 2017. One of the conditions stipulates the need to *"notify the Administrator of the Committee, in writing, of any modifications or replacement of the Operation and Maintenance Agreement within sixty (60) days of such modification or replacement..."*

The Scope Change Order No. 01 was signed off and made effective on December 11, 2019 and amended to the SMA dated October 11, 2016. The changes are as following:

1- Section 4.6 Owner-Provided Third Person

During times when Contractor requires three (3) personnel to be on-site for safety purposes, as defined in the Contractor's EHS Manual developed for the site, Contractor shall provide one additional on-site person who is certified for climbing through Siemens Advanced Rescue Training (such training and certification to be provided by Siemens at no cost to Owner) in order to assist Contractor in case of rescue. All such times shall be scheduled during normal business hours and Contractor shall have three (3) Business Days' to provide an additional onsite person. Any downtime of the Units during the three (3) Business Day period shall not be counted against Contractor for the purposes of the Availability Guarantee."

2- Exhibit A1 to the Agreement, titled "Scope of Contractor's Services 200A", shall be replaced and superseded in its entirety by Amended Exhibit A1, Scope of Contractor's Services 200A.

3- Exhibit A2 to the Agreement, titled "Scope of Contractor's Services 300W", shall be replaced and superseded in its entirety by Amended Exhibit A2, Scope of Contractor's Services 300W.

4- Contractor shall provide Balance of Plant and Safety Training for Owner Personnel (the "Training") once per Site, per year for two (2) years following the Effective Date.

5- The Parties agree that Contractor shall perform an additional scope of work ("Additional Work") upon written request by Owner.

6- The Additional Work shall be performed and charged on an hourly basis in accordance with the 1720W Price List, attached in the scope change order as Attachment 5.

As the Scope Change Order No. 1 contains confidential commercial information, the document and its Appendixes/Attachments would be available at the Antrim Wind Energy Operation & Maintenance building and available upon request by the NHSEC administrator.
