Dear Ms. Monroe:

Thank you for your email. I read the letter filed by Representative Vose and Senators Ward and Giuda and share the concerns they raise.

First, I have no issue with, and fully expect that any of my communications to the SEC will be posted on the Committee's website regardless of any responsive actions that might follow. To my knowledge, this has been the process followed by the SEC in proceedings that predate the addition of an administrator and it's consistent with Site 104.01(f) ("The committee shall post public information on its website at [www.nhsec.nh.gov](http://www.nhsec.nh.gov)"). Groton Wind under Docket 2010-01 is one example where a complaint was filed and posted to the SEC site before any action was taken by the Committee. It's not clear to me why privacy is now an issue.

Second, I would like to respond to this statement in your email: "To the extent that more formal requests for enforcement are submitted, that information is posted." This is not at all how you handled the Feb 28 letter signed by 17 Antrim residents describing failures with Antrim Wind's ADLS system.

While you posted Antrim Wind's responses on the SEC website, you left our letter off the site giving the false impression that Antrim Wind and/or you proactively reported and resolved the problem. As you should remember, you admitted to me that you were unaware of the problem until you received our letter. The ADLS problem continues to be unresolved.

Thank you again for your email. I ask that this communication be posted to the SEC website as well.

On Friday, April 17, the Chairwoman of the SEC received a letter from Senator Ward, Senator Giuda, and Representative Vose regarding constituent concerns about certification of non-compliance related to the Antrim Wind facility. The letter requested an investigation by the Chairwoman or the full SEC.
