As you know, we are still pending a determination on our waiver request of July 24, 2020 regarding the schedule and location for the post-construction sound monitoring. With the 2020 summer coming to an end soon and the absence of determination/direction from NHSEC, we believe it is in the public interest that sound measurement during the summer be done sooner than later even if only at the accessible locations. With that in mind, I thought it would be best to email you to inform you of our intention to mobilize at location L1, L2, L3 and L5 on August 31<sup>st</sup> to install the sound measuring equipment. Please let us know if you have any concerns with this course of action.
