Access request for location L4 located at 72 Reed Carr Road**


Dear Ms. Barbara I. Berwick and Mr. Bruce E. Berwick,

I'm writing today on behalf of Antrim Wind Energy (AWE) regarding our upcoming mobilization for the spring 2021 post-construction sound monitoring. One of the locations used during the preconstruction sound measurements, L4, is located on 72 Reed Carr Road and you are identified as the owners as per the Town of Antrim's Residential Property Assessment Records. Per the NHSEC Certificate¹ and the Town Agreement², and as per the January 5, 2021 order³ from NHSEC, we humbly seek your permission to access lands located at 72 Reed Carr Road to perform the post-construction sound measurements at the same location L4.

Should you agree to grant permission, the instrumentation will be deployed by our acoustical consultant for about two weeks sometime between March 21st and June 21st. We will provide you with a one-week notice before initial mobilization, and a one day notice prior any equipment check visit and the demobilization. Please let us know by March 21st if you agree to grant permission so we can plan our sound monitoring campaign accordingly.
