541-A:31 Availability of Adjudicative Proceeding; Contested Cases; Notice, Hearing and Record. –

VII. The entirety of all oral proceedings shall be recorded verbatim by the agency. **Upon the request of any party or upon the agency's own initiative, such record shall be transcribed by the agency if the requesting party or agency shall pay all reasonable costs for such transcription. [...]**
