# Re: SEC Docket No. 2015-04: Public Service Company of New Hampshire d/b/a Eversource Energy for a New 115 kV Transmission Line from Madbury Substation to Portsmouth Substation Applicant's Order of Witnesses for Upcoming Technical Sessions

Dear Ms. Monroe:

Enclosed for filing in the above-captioned docket, please find the Applicant's Order of Witnesses for Upcoming Technical Sessions. On April 27, 2017, the Applicant's solicited input from all parties in this docket regarding an estimated amount of time each party may need to inquire of each of the Applicant's witnesses or witness panels. The parties that responded generally informed the Applicant that its request for rough time estimates was premature. Some of the parties further stated that they could not provide an estimate of time needed at the technical sessions until they received and reviewed the Applicant's responses to data requests relating to the Amendment filed on March 29, 2017 and the Normandeau Characterization of Sediment Quality Along Little Bay Crossing Report submitted to the Committee on December 1, 2016.

The Applicant is concerned, however, that the dates of the technical sessions are fast approaching and that the parties may not have sufficient time to prepare for the earlier sessions. Therefore, the Applicant is submitting its Order of Witnesses for the Upcoming Technical Sessions, which is based on the Applicant's best estimates for each witness or witness panel. As noted in the submittal, the Applicant's time estimates are just that—estimates. Each witness or witness or witness panel will only appear on the day listed because many witnesses are travelling from out-of-state. Therefore, should questioning go beyond the estimated times on a particular day, the Applicants suggest the parties be prepared to stay later than 5:00 PM to complete the questioning on that day.

Also, the Applicant has included one additional technical session day in its Order of Witnesses, which is necessary because of scheduling constraints for one of the Applicant's witnesses, namely, Dr. James Chalmers, who cannot appear on any of the assigned technical session dates,

but can appear on the morning of May 26, 2017. The Applicant sought input from all of the parties on April 12, 2017 regarding this issue. The only party that responded was Counsel for the Public, who indicated that they were available on May 26, 2017 to question Dr. Chalmers.
