

**PARTIALLY ASSENTED-TO MOTION TO ALLOW LATE-FILED INTERVENOR
TESTIMONY**

Jeff and Vivian Miller and Dr. Regis C. Miller are intervenors in the above-captioned proceeding and respectfully submit this motion pursuant to N.H. Admin. Rule Site 202.14 and request that the New Hampshire Site Evaluation Committee ("Committee") allow them to file the attached testimony. In support of this motion, the intervenors state:

1. On August 24, 2016, the Committee approved the interventions of Jeff and Vivian Miller and stated that "[i]n order to avoid duplicative arguments and to ensure the prompt and orderly development of these proceedings, their participation in this docket shall be combined for the purposes of presentation of evidence, argument, cross-examination, and other participation." Order on Petitions to Intervene, dated August 24, 2016, at page 10.
2. On May 25, 2017, the Committee granted the intervention of Dr. Regis C. Miller and stated that: "[i]n order to avoid duplicative arguments and to ensure the prompt and orderly conduct of the proceedings, Dr. Miller's participation in this docket shall be combined for purposes of presentation of evidence, argument, cross-examination, and other participation, with the "Durham Residents" group of intervenors." Order on Late-Filed Motion to Intervene, dated May 25, 2017, at page 4.
3. In attempting to avoid duplication, Jeff and Vivian Miller and Dr. Regis C. Miller worked with the other Durham intervenors and Town of Durham and believed that their concerns

would be brought before the Committee through testimony from the other intervenors or Town of Durham.

4. Since the filing of testimony on July 31, 2017, Jeff and Vivian Miller and Dr. Regis C. Miller have realized that some of their concerns have not been raised by Durham intervenors or the Town of Durham.

5. In addition, certain concerns were not known at the time that the testimony was due on July 31, 2017. They are:

- a. Impacts of DES recommendations may have on Little Bay and the method used for the cable crossing.
- b. Incomplete or inadequate visual assessments for concrete mattresses at low tide.
- c. No method to assess property value loss.
- d. Detailed tree clearing plan not provided.
- e. Unclear if we will have limited access to our driveway and home during construction.
- f. Unclear time line for construction and restoration.
- g. What process will be put in place to address and remedy any damage to our house and property.

6. To provide a complete list of concerns, Jeff and Vivian Miller and Dr. Regis Miller request the Committee accept the attached testimony. Jeff and Vivian Miller and Dr. Regis Miller agree to be subject to discovery over the attached testimony similar to the discovery that occurred after the July 31, 2017 testimonies were filed.

7. Jeff and Vivian Miller and Dr. Regis Miller do not believe waiting to file the testimony as supplemental testimony on July 27, 2018 or waiting to voice their concerns as public statements advances the orderly development of the docket because it makes their concerns known later, and perhaps too late to be the subject of memoranda of understanding or settlement agreements. Jeff and Vivian Miller and Dr. Regis Miller prefer to make their concerns known sooner rather than later.

8. The following parties assent, oppose, or take no position on this filing. Any party not listed did not respond by the time of filing.
