

14 Abutter Notification (Env-Wt 101.03, Env-Wt 501.01(c), 501.02(a)(1)& 505.01(f))

Per, Env-Wt 501.01(c) abutter notification is not required for projects in utility ROWs; therefore abutter notification has not been completed for the portions of the Project located in existing and/or proposed utility ROW areas.

A list of abutters to the nine development sites associated with the six proposed transition stations, the proposed Franklin Converter Station, and the two proposed existing substation expansions is included below. These portions of the Project are not located in a traditional utility ROW; however they are located adjacent to a utility ROW and are a critical part of the Project. Parcels across public roads and abutting parcels more than 1/4 –mile from the limits of disturbances are not included. Parcels owned by PSNH and/or the Project are not included in the list of abutters.

It should be noted that the Project has conducted and will continue to conduct proactive outreach actions throughout Project permitting and construction, and public hearings will take place in accordance with SEC rules.

In addition, public hearings and other outreach are associated with the Northern Pass Environmental Impact Statement (EIS) process which is led by the U.S. Department of Energy as required under the National Environmental Policy Act (NEPA). As of October 2015, the current public comment period to receive comments on the Draft EIS is extended to close December 31, 2015 and public hearings to receive oral comments on the Draft EIS and the Supplement to the Draft EIS will be held prior to the close of the public comment period. Dates, times and locations of the public hearings will be announced when available.
