Holderness Selectmen and town will meet with the Northern Pass Reps :There will be an information meeting on Northern Pass in Holderness on Thursday, February 10th starting at 6:30 at the Holderness Central School on Rte. 175. For more information call 536-2279. Pass on this information to anyone from or close to Holderness.

February 8 House bill 302 the NH Science, Technology and Energy Committee will be having a public hearing in room 304 at the Legislative Office Building . More information below. Deborah Reynolds is looking into what needs to be accomplished to hold a press conference of the No Northern Pass Coalition to follow that. There will be buses going out of many locations as well as people driving so if you wish to go and need a ride please let me know and I will forward you information on buses (I do not have that information yet). The house bill noted above is part of this rouse. Currently large hydro does not meet the national or State of NH energy definition of green and renewable energy because it has more down side to the environmental impact then its benefit . NH has no large hydro plants and given its environmental laws can not even if it has a body of water large enough to support a large hydro - which it does not have . This bill is simply brought into existence for the purpose of making way for the Northern Pass and its bid for eminent domain.

HB 302

Here is more information on the Public Hearing for House Bill 302 before the Science, Technology and Energy Committee on Tuesday, February 8th in Concord at the Legislative Office Building - Room 304 at 1:00 am. Although the proposed bill doesn't directly address Northern Pass it changes the energy portfolio for hydro power in NH and support for small hydro projects. In other words it opens the door to large hydro projects such as Northern Pass.

Committee Procedures and What to Expect

It's important for people who are concerned about the project to attend the hearing and make comments. **When you go down, be sure to have a written copy of your comments since in many cases there won't be time to have everyone heard so if it is written it will be on the record.** Spoken comments alone may be forgotten. When you first get there you must sign a card to indicate that you wish to speak. If you would like to participate, but not speak you should still attend and can leave your written comments for the committee to review. GIVE YOURSELF PLENTY OF TIME TO FIND PARKING IN DOWNTOWN CONCORD.

Talking points

You will, of course, have your own argument to make. These may include the fact that the purpose of passing the renewable

energy portfolio legislation initially was to encourage the growth of smaller, local projects that are considered "green" by

EPA standards. Big hydro is not classified as "renewable" but not as "green" ("clean") by the EPA:

Renewable energy includes resources that rely on fuel sources that restore themselves over short periods of time and do not diminish. Such fuel sources include the sun, wind, moving water, organic plant and waste material (biomass), and the earth's heat (geothermal). Although the impacts are small, some renewable energy technologies have an impact on the environment. For example, large hydroelectric resources can have environmental trade-offs associated with issues such as fisheries and land use.

HOW to Comment on the DOE 's Environmental Impact Statement (EIS) for WMNF:

The WMNF is now listing the Northern Pass on its SOPA (Schedule of Proposed Action) list. See attached "snip" from the WMNF site. I wrote to the WMNF asking how to comment on this SOPA; public comment periods are always included for proposed actions. I received the answer below from Stacy Lemieux in the Campton headquarters of the WMNF. You may also wish to ask her to have your email address added to the list, per her second paragraph below, so that you may have the earliest opportunity possible to comment. This is all moving ahead with the greatest haste.

Email from Stacy Lemieux:

Tiffany Benna forwarded me your note below as I have been in touch with the US Department of Energy, who has primary responsibility for the environmental analysis for this project. The Dep't of Energy is finalizing a Notice of Intent to prepare an environmental impact statement. They expect that Notice of Intent to be published in the Federal Register in the next week or two. That publication will begin the scoping period, which is the first public comment period for this project. The comment period will last until a week after a round of public meetings, which will be held in March. The details on the public meetings and the comment period, including where to send comments to will be included in the Notice of Intent. I do not know the Dep't of Energy website for this project. Once we have that information, we will include it on our Forest project website to help people find the pertinent info.

I will forward your email address to the contractor who will be sending word to everyone who has expressed interest in the project when the Notice of Intent is available so that you can be added to their mailing list. That way you will hear about the start of the comment period and how to comment as early as possible.

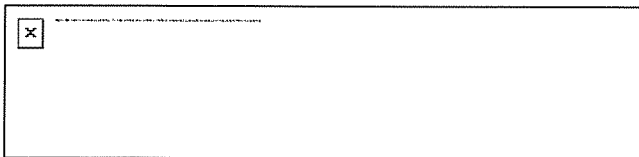

#### **INFORMATION ON WHAT HAPPENED RECENTLY:**

Just a recap of what took place over the last two weeks . The Northern Pass representatives came to meet with the Selectmen of Ashland and citizens of the town to inform them about the Northern Pass project. There were approximately 50-60 citizens of Ashland most of whom were opposed to the project in attendance . The following is an outline of the topics from this meeting sent to us from Kelly Weiser. This meeting took place on January 17

I am responding to this group as you were addressed earlier about the Ashland meeting. I also added Bury Northern Pass. I have just returned from the meeting in Ashland where I observed a polite, well-informed and eloquent public respond to the Northern Pass presentation. It is the type of questions asked and statements made at this meeting that will show Northern Pass that the people of New Hampshire are a force to be reckoned with. Some of the highlights:

Q: Do we need this power in New Hampshire?

A: No, we have adequate power in New Hampshire but this is low cost power and better from an environmental perspective.

Q:PSNH is the largest company in the State of New Hampshire. Some people might be open-minded enough to think that this project could be good for New Hampshire. Would PSNH shut down all the other sources of power produced in New Hampshire and provide this lower cost power to New Hampshire? What is the cost going to be? We should get this lower cost power if it is going to go through our state.

A: That is a valid point; this is a catch-22, we do not know yet what it is going to cost but we will get the information out as soon as we can. The prices are confidential for now.

Q: New Hampshire is producing 4,000 Megawatts of power and consuming 2,400 Megawatts. How will this project influence power generators in the state - if you bring in cheaper power, are they going to go out of business?

A: This is a 40 year agreement. New Hampshire may need more power as it grows and increases in

population. This is better for our customers and New England.

Q: To which the questioner responded: So is it New Hampshire that needs this power or other states?

A: This is lower carbon, cleaner power (etc. talking points).

Q: Did PSNH do an RFP to domestic generators of power for 4,000 Megawatts prior to making an agreement with a foreign company?

A: No. This is the least expensive, lowest carbon we can get. That is why we worked a deal with Hydro-Quebec.

Q: To which the questioner responded: How do you know if you did not do an RFP?

A: We don't know. The rest [of the options] are at higher prices requiring a subsidy.

Q: You spoke about an increase in tax base but this line would run the entire length of Ashland so would my property be devalued if it is along the line or views it?

A: Studies have shown that property is not significantly impacted if away from the line and just viewing it. Besides, we will pay the property owner for the easement.

Q: To which the questioner responded: Some of the easements are not wide enough. Do you have to buy our property for a fall zone?

A: These towers collapse in place. The conductors hold them in place. They are designed for the weather conditions in this region. They collapse in place.

Q: To which the questioner responded: They said the Titanic would not sink.

A: No response.

Q: A statement was made by a different member of the audience to the effect that: The Real Estate Board said that values can decline as much as 40% or more and some appraisers have already stated that some affected properties may be unmarketable.

A: No response.

Q: A different member of the audience relayed that the reductions can be as much as 75% of value.

A: No response.

Q: I have been to Canada and has seen the signs warning of falling ice dangers. School buses, cars people pass under these lines. I would not want to pass under them. It is unfair for you to think that we would swallow this as a good thing for our communities.

A: No response.

Q: Cheap power - what does this mean? The people of New Hampshire deserve a definition of 'cheap power,' we deserve to know what this is if you want our support, which I do not think you have much of. If you have all the information then you should know what this is going to cost.

A: We are in negotiations. I don't know personally and can't say now. We won't do it if it doesn't make economic sense because there is not any reason to.

Q: I have seen this listed as a high voltage DC line. Is it the only such line in NH?

A: No, there are others. There is a portion of a line from Canada to Massachusetts that passes through the southwest corner of New Hampshire. The structures you have in New Hampshire (referring to this small section) are for 450K volts and this is for 300K volts.

Q: To which the questioner responded: So can you help the public understand - is this more or less dangerous than AC power?

A: Less because it has less power and can be shut off quicker.

It is clear that it is important to make sure that citizens of any of the towns where they present are aware, informed and attend the meeting, as the people in Ashland were/did. I had not been to one of these presentations yet and in their initial presentation they stressed that there would be lots of opportunity for public input - as part of the DOE process, the USDA process, the SEC process. I think that we need to make sure at

other meetings in the future that some questions are asked about the impact on tourism - have they quantified that? **It is important to note here that they said they will be involved in outreach with each of the state agencies involved in the SEC ahead of time to find out "where they stand, what their concerns are..."** It seems it would be inappropriate for anyone on any side of this to have contact with officials outside of the appropriate process. Don Chase presented most of this meeting and Pat (did not catch last name) gave the overview and responded to some questions.

On the 24th there was meetings with the Lakes Region Planning Commission in New Hampton with Northern Pass. As I was out of town I have little information on this meeting other then the Northern Pass was represented by a different speaker then the last meetings and that there was good turn out .

Also on the 24th there was a meeting at the Woodstock Station for informational for those opposed and those that wanted to find out more information on the opposition . This had a standing room only turn out.

In Colebrook there was a meeting of those opposed to the Northern Pass on February 28th in Colebrook . It was called "Landowners- You are not alone ". It was put together to educate property owners that are being approached by Northern Pass for their easements what their rights are and to talk to people about the issue of eminent domain. There was a turn out of 300 give or take. Most were radically opposed to the Northern Pass but a few were there to find out about the issue of eminent domain.

Eminent Domain is going to be a serious issue in the near future as because of the opposition that they are experiencing Northern Pass is not likely to get the easements that they will need to do this project without being able to take property by eminent domain. The law regarding eminent domain requires that no property can be taken for a project that is to benefit a private company as in this case . It must be for the public good. Because of this, Northern Pass is changing its tactics to make an end run to get status as a Public Utility. If they are serving the public of NH , then they can make a play as a public utility (verses a private LLC Limited Liability Corporation) to be able to take land via the eminent domain laws. In order to do this they are in the process of trying to purchase 100 of the 1200 KW that will be transmitted over the lines so that they can fake serving the NH public. I say fake as NH is currently and has been for some time now, a net exporter of power. This means that we make more than what we use and we export the power that is in excess. So purchasing 100 KW or 1 is more than is what is needed for this State. The purpose of this is a simple endrun to circumvent NH public laws and private rights of its citizens. Since there is no benefit to NH's public and land taken by eminent domain will not be for the public good . The house bill noted above is part of this rouse. Currently large hydro does not meet the national or State of NH energy definition of green and renewable energy because it has more down side to the environmental impact then its benefit . NH has no large hydro plants and given its environmental laws can not even if it has a body of water large enough to support a large hydro - which it does not have . This bill is simply brought into existence for the purpose of making way for the Northern Pass and its bid for eminent domain.

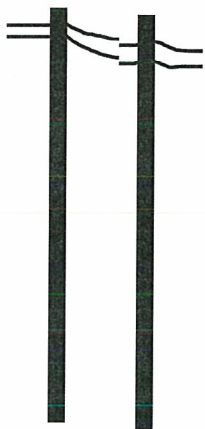

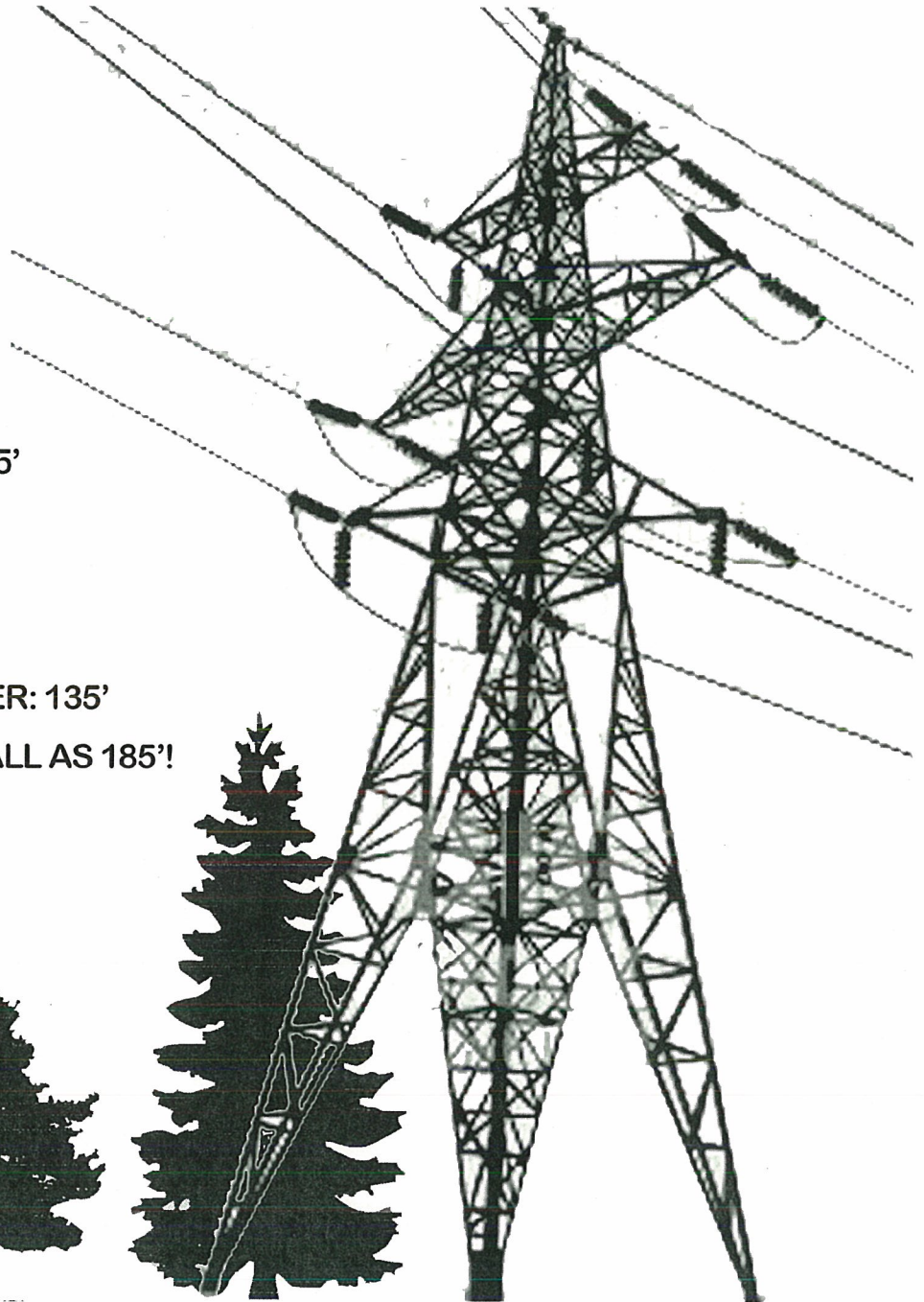
