**NOTICE OF PUBLIC HEARING**

**Tennessee Gas Pipeline Company Londonderry 20" Replacement Project**

**Motion of Tennessee Gas Pipeline Company (Tennessee) To Amend and Clarify the  
Certificate of Site and Facility**

On December 28, 2000, the Site Evaluation Committee (Committee) issued a Certificate of Site and Facility to Tennessee to construct, install and operate 19.3 miles, of 20 inch replacement pipe commencing in Dracut, Massachusetts and terminating in Londonderry, New Hampshire; and to construct, install and operate delivery point facilities, including a meter station, to allow Tennessee to provide firm gas transportation service of up to 130,000 dekatherms per day of natural gas to a new industrial end-use customer, AES Londonderry, L.L.C. (AES).

On May 25, 2001, Tennessee filed a Motion to Amend and Clarify the Certificate of Site and Facility. Tennessee requests the Committee to issue an Order amending the certificate to reflect a relocation of a portion of the pipeline located in Londonderry, N.H., and amending Condition 58(g)(iv) which is contained in Attachment B of the Certificate. Specifically, Tennessee seeks authority to relocate that portion of the pipeline that extends for approximately 0.46 miles between mileposts 104+5.61 and 104+6.07 to a position approximately 200 to 300 feet west of the original proposed location. Tennessee also requests the Committee to amend Environmental Condition 58 (g)(iv) in its application to "wet" and "dry" surface water crossings.

The original Application, the Certificate of Site and Facility, transcripts of prior hearings and Tennessee's Motion to Amend and Clarify the Certificate of Site and Facility may be viewed at the offices of the Department of Environmental Services, 6 Hazen Drive, Concord, New Hampshire or at the Town Offices in Londonderry, Windham, and Pelham, New Hampshire.

It is hereby **ORDERED**, that a public hearing be held on Tennessee's Motion to Amend and Clarify the Certificate of Site and Facility at the following date, time and location:

The applicant shall file an affidavit documenting publication on or before July 2, 2001.
