On March 16, 2001, Sprague Energy Corporation (Sprague) filed an Application for Exemption - Sprague Pipeline with the Site Evaluation Committee. The Sprague Application seeks exemption from the requirements of RSA 162-H for the siting, construction, installation, maintenance and operation of a six inch inside-diameter fuel transfer pipeline to supply low sulfur diesel fuel, as a back up source of fuel, to the 525 megawatt Newington Power Facility being constructed by Newington Energy, LLC (NEL), in Newington, County of Rockingham, New Hampshire. The proposed pipeline, if approved, will be built from two existing aboveground storage tanks (AST's) located at Sprague's existing facility in Newington, NH, and will traverse aboveground on Sprague property for approximately 1,120 feet and underground for approximately 700 feet to River Road. The pipeline is then proposed to run underground and parallel to River Road and along the northeast side of a proposed Industrial Corridor Road (ICR) for approximately 4,600 feet until it diverges and terminates at the NEL AST.
