# MOTION FOR PROTECTIVE ORDER AND CONFIDENTIAL TREATMENT FOR APPENDIX Q (ISO-NE INTERCONNECTION FEASIBILITY STUDY) TO THE APPLICATION FOR A CERTIFICATE OF SITE AND FACILITY

Applicant Laidlaw Berlin Biopower, LLC ("LBB"), respectfully requests that the Site Evaluation Committee (the "Committee") issue a protective order to maintain the confidentiality of the ISO-NE Interconnection Feasibility Study submitted as Appendix Q to LBB's Application for a Certificate of Site and Facility. In support of its motion, LBB states as follows:

- 1. LBB seeks confidential treatment pursuant to RSA 91-A for the ISO-NE Interconnection Feasibility Study (the "Study") attached as Appendix Q to the Application. LBB did not originally request confidential treatment for this document. Subsequent to filing the Application, ISO-NE contacted LBB and requested that the Study be treated as confidential pursuant to ISO-NE procedural rules and because the document contains confidential, commercial information and critical energy infrastructure information.
- 2. Because the Study contains confidential, commercial and financial information, it is exempt from public disclosure under the New Hampshire Right to Know Act. RSA 91-A:5, IV. The Committee has the authority pursuant to RSA 91-A:5, IV to protect this information.

WHEREFORE, LBB respectfully requests that the Committee:

- A. Issue an order protecting the Study;
- B. Seal Appendix Q to LBB's Application; and
- C. Grant such other and further relief as may be just and equitable.
