

TOWN OF RUMNEY'S PETITION TO INTERVENE

NOW COMES the Town of Rumney ("Town"), by and through its attorneys, Gardner Fulton & Waugh P.L.L.C., and petitions the Site Evaluation Committee, pursuant to RSA 541-A:32 and Site 202.11, to allow the Town to intervene in the above captioned matter for the following reasons:

1. On March 26, 2010 Groton Wind, LLC filed an Application for a Certificate of Site and Facility for the siting, construction and operation of a wind farm consisting of 24 wind turbines to be located in the Town of Groton, many of them sited immediately adjacent to the Rumney Town Line.

2. The rights, duties, substantial interests of the Town of Rumney and its residents may be affected by the present proceeding. In particular the access to the wind turbine site will be via a public highway maintained by the Town of Rumney; the power line transmitting power from the project is projected to run through the Town of Rumney, and the wind turbines themselves will be visible from throughout Rumney.

3. The interests of justice and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.




