Dear Committee Members,

1. My name is Lawrence A. Mazur,MD and I reside with my family at 774 Quincy Road,Rumney,New Hampshire 03266, just across The Baker River Valley from the proposed Groton Wind,LLC installation site.

2. I am a Certified Diplomate in Adult Psychiatry of The American Board of Psychiatry and Neurology since 1982, having had opportunities to practice medicine in various locales within The United States and abroad during the past 35 years.

3. As a concerned resident of The Baker River Valley I am very worried about the health-hazard risks to involuntary innocent humans engendered by the possibility of Committee Approval for The Groton Wind,LLC Application and otherwise referred to within this country and abroad as Wind Turbine Syndrome, Wind Turbine Syndrome Spectrum Disorder and their related illness,Vibro-Acoustic Disease. There appears to be a great deal of opinion diversity regarding whether or not these illness entities are of need for concern, marked only by a lack of respectable,laboratory-designed,variable-controlled hypothesis-testing research of the field-data which various clinicians in different countries keep bringing to the Public's attention. Recent reference alluded to by U.S. Secretary of Energy Chu as a "peer review" monograph on this subject has also acknowledged lack of appropriate laboratory-designed research to test these issues having ever been performed.

4. Although published medical literature on the overlapping of psychophysiological/psychosomatic inner-ear disease has been referenced back to 1895 by H.Flanders Dunbar,MD,PhD (1935) with recommendations on how to experimentally tease apart such concerns, and psychoneuroimmunological approaches applicable to neurotological illness referenced in diverse textbooks dating at least to 1981(as shared with the Committee earlier in this process),recent communications received from The National Institutes of Health still confirm a need for well-financed,respectable and definitive research still yet to be done in further delineating health-hazard risks conceivably associated with the application now before you for consideration.

5. Until which time The United States Government's Department of Health and Human Services, perhaps in collaboration with The World Health Organization and other like-minded, health-conscious organizations whose primary mandate is to protect the health of innocent human beings, can unqualifiedly bless such projects with no health-hazard risks within parameters acceptable to applicable regulatory agencies, a cease and desist moratorium should be called into effect on The Groton Wind, LLC Application at this time.
