Dear Sirs:

We thank you for the opportunity to have participated in the past year's review process and this opportunity to share our summarizing position.

We beg you on bended knee not to approve the application of Groton Wind and its request for permission to build this project. This project will be of little value to the people of New Hampshire, will jeopardize the health and quality of life of the residents of The Baker River Valley, will have a very negative impact on tourism of the area, and have a disastrous effect on real estate values. (See testimony by Michael McCann). While generating a relatively small amount of electricity, it would be a threat to both the environment and the wildlife of New Hampshire including the protected peregrine falcon. Further, this project is a poor investment, only made possible by government subsidies which would be granted to Iberdrola Corporation at a time when the Federal Government can ill afford to squander taxpayer money.

While all these issues and many others are of great importance (We refer you to those issues listed in the "Resolution Petition" posted on the SEC site on Jan. 10, 2011), health issues remain the chief concern for those of us who would have to live within a few miles of the proposed wind facility. The applicant assumes a negligently cavalier position regarding these concerns for convenience sake. It denies disastrous visual impact. It denies obnoxious shadow-flicker. It denies wind turbine syndrome and vibroacoustic disease. The applicant's attitude reminds us of the attitudes expressed by other industry groups such as those for natural gas "fracking" and mountain top removal coal production, for whom health concerns and environmental risks are downplayed, and for whom profit is the only concern.

Do not ignore the testimony of people who are living in close proximity to wind projects both here and abroad. Through their experience of living near wind facilities, they are the only experts. Listen to the people of Mars Hill, ME; Tug Hill, NY; Meyersdale, PA; Falmouth, MA; Vinalhaven, ME; and many other locations.

Some will choose to ignore the clear health risk from wind turbines in the same way the dangers of cigarette smoking were ignored in previous decades. But please look at the evidence. People's health has been affected. Their quality of life has been affected. They have been driven from their homes by the noise. The value of their homes has been destroyed. They have been devastated. Do the right thing. Protect the people of Rumney and The Baker River Valley. Vote against this project proposal.
