## MOTION TO RECONFIGURE INTERVENOR GROUPS

The above named intervenors all reside in the North Branch region of Antrim and own property in the immediate vicinity of the proposed wind turbine facility. In the appeal procedures conducted by the Antrim Planning Board and Zoning Board of Adjustment over the last two years regarding Antrim Wind Energy LLC's applications, most of this group served as appellants. Applicant) and to Attorney Justin Richardson (Counsel for the Town of Antrim.) In response, Attorney Richardson wrote that the Town of Antrim takes no position on the motion. We have not received a response from either Attorney Goldwasser nor from Attorney Geiger.
