**Re: Application of Antrim Wind Energy, LLC for a Certificate of Site and Facility

Hillsborough County, New Hampshire**

**Order Designating Subcommittee Pursuant to RSA 162-H: 6-a**

**Issued March 20, 2012**

On or about January 31, 2012, Antrim Wind Energy, LLC (Applicant) filed an Application for a Certificate of Site and Facility for a renewable energy facility proposed to be located in Hillsborough County, and the Town of Antrim, New Hampshire (Application). The Application proposes the construction and operation of a wind powered electric generation facility consisting of 10 wind turbines, each having a nameplate capacity of not more than 3 megawatts (MW) for a total nameplate capacity of 30 MW and associated facilities including an electrical collection system with both underground and overhead collection lines, an interconnection substation, and an operations and maintenance building, along with approximately 4 miles of new gravel surfaced roads within the proposed project area. On February 9, 2012, pursuant to RSA 162-H:6-a, II, Committee Chairman, Thomas Burack, appointed me to review the Application in order to determine whether it consisted of sufficient information to carry out the purposes of RSA 162-H. Chairman Burack has indicated that he has a personal conflict that would prohibit him from serving as a member of a Subcommittee in this matter. As statutory Vice-Chairman of the Committee I will serve in place of Chairman Burack. See, RSA 162-H: 3.

On March 5, 2012, I issued an Order finding that the Application contained sufficient information to carry out the purposes of RSA 162-H and accepted the Application.
