MOTION TO INTERVENE PRO SE OF James A. Hankard

Pursuant to the New Hampshire Site Evaluation Committee Rules Site 202.11, James A. Hankard hereby moves] for permission to intervene pro se in the above-referenced proceeding. In support of his Motion to Intervene, James A. Hankard offers the following arguments:

(1.) James A. Hankard can demonstrate a substantial interest which may be affected by the outcome of the proceeding.

My home will lie within close proximity to this proposed Industrial Wind Project. I am extremely alarmed over the amount of noise that these turbines will generate. It has been documented repeatedly that the noise is sufficient to make people ill and drive them from their homes, as has been the case in Lempster, NH. I currently suffer from several chronic ailments as it is and I can't begin to imagine the further compromise that these wind turbines will have to my health! The thought that I will have to view these structure that will be taller that the Empire State building on a daily basis is depressing to say the least! I moved to Antrim for a peaceful, rural lifestyle. If these Wind Turbines are constructed, I may as well live next to an airport! I am also very concerned about the guaranteed devaluation of my home and property. IF I where to have to sell my home if and when this project is allowed, I would not even receive half the amount of money that I paid for my home originally! The Town of Antrim does not benefit from this proposed project at all!! Also, the negative impact to wildlife in this are will be overwhelming! The impact upon the rural conservation area and Greg Lake in Antrim will be devastating.

(2.) The interest of James A. Hankard will not be adequately protected by other parties.

In exercising its discretion, James A. Hankard respectfully ask that the Committee consider whether other parties will adequately protect the party's interest. Since James A. Hankard, as a resident of the North Branch region of Antrim where the proposed wind facility would be constructed, do not feel that my interests and concerns have been addressed thus far in proceedings by the Town Boards of Antrim, James A. Hankard do not believe that any other party to this proceeding can adequately represent my interests in proceedings before the Committee.

(3.) The intervention of James A. Hankard will be in the interest of justice and will not impair the orderly and prompt conduct of the proceedings by allowing the intervention.
