#### MOTION TO INTERVENE PRO SE OF [name]

Pursuant to the New Hampshire Site Evaluation Committee Rules Site 202.11, Clifton R. Burdette hereby moves for permission to intervene *pro se* in the above-referenced proceeding. In support of their Motion to Intervene, Clifton R. Burdette offers the following arguments:

## (1.) Clifton R. Burdette can demonstrate a substantial interest which may be affected by the outcome of the proceeding.

Description of interest: health issues caused by the magnetic resonance of the wind mill generators, concern over property values and/or the ability to even sell a house that less one mile or less from the windmills, constant noise pollution from the windmills due to their close proximity to my home, and concern over increase in homeowner taxes due to Antrim becoming a donor town for Con Val School District.

#### (2.) The interest of Clifton R. Burdette will not be adequately protected by other parties.

In exercising its discretion, we respectfully ask that the Committee consider whether the party's interest will be adequately protected by other parties. Since we, as residents of the North Branch region of Antrim where the proposed wind facility would be constructed, do not feel that our interests and concerns have been addressed thus far in proceedings by the Town Boards of Antrim, we do not believe that any other party to this proceeding can adequately represent our interests in proceedings before the Committee.

# (3.) The intervention of Clifton R. Burdette will be in the interest of justice and will not impair the orderly and prompt conduct of the proceedings by allowing the intervention.

Pursuant to the SEC Order of March 20, 2012, Clifton R. Burdette files this Motion to Intervene by the deadline set forth by the Committee for Docket 2012-01 and requests that I be permitted to intervene with full standing to participate in all phases and activities of the proceeding. I respect the importance of conducting this proceeding in an orderly manner that will not unduly delay the Committee or the parties in reaching an outcome. I am prepared to work closely with other parties to the proceeding in the interest of maintaining order and respectfully offer that [my our] participation, if permitted, would be in the interest of justice.
