Petition for Jurisdiction over a Renewable Energy Facility Proposed by Timbertop Wind I, LLC, to be Located in Temple and New Ipswich (Hillsborough County New Hampshire)

Adjudicative Proceeding

BACKGROUND

The Timbertop Wind I, LLC Project ("Facility" and/or "Project") is a proposed wind energy facility consisting of (5) Siemens SWT turbines each having a nameplate capacity of 3 MW. The Facility is proposed to be located on Kidder Mountain in the towns of Temple and New Ipswich, Hillsborough County, New Hampshire.

On December 21, 2012, Timbertop Wind I, LC ("Petitioner") filed a Petition for Jurisdiction ("Petition") with the New Hampshire Site Evaluation Committee ("Committee") requesting the Committee to exercise jurisdiction over the siting, construction and operation of the Facility to be located in the Towns of Temple and New Ipswich, Hillsborough County, New Hampshire pursuant to RSA I62-H:2, XII.

On February 14, 2013 the Attorney General appointed Senior Assistant Attorney General Peter C.L. Roth as counsel for the public in this matter.

On February 19, 2013, a public hearing was held regarding the Petition. At the hearing the motion by the Towns to intervene was granted. The Towns' motion to dismiss the Petition was orally denied. The parties were directed to meet with counsel to develop a proposed procedural schedule. On April 19, 2013, a motion to dismiss the Petition filed by the Towns was denied in writing. A motion for reconsideration of the oral decision to deny the motion was likewise denied.

On April 25, 2013 the Petitioner filed a motion for deliberations and procedural schedule. The motion was assented to by the Towns and Counsel for the Public. On May 8, 2013 the motion for deliberation and procedural schedule was granted. In accordance with the order granting the motion for deliberations and procedural schedule the adjudicative proceeding shall be conducted on the written record as supplied by the parties.
