**Request of SEA-3, Inc. for Exemption from
the Approval and Certificate Provisions of RSA Chapter 162-H
October 8, 2015**

AGENDA FOR TECHNICAL SESSION ON OCTOBER 14, 2015

Consistent with the Presiding Officer's Order dated September 4, 2015, a Technical Session will be held in this docket on October 14, 2015. The Technical Session shall begin at 9:00 A.M. The scope of questioning at this Technical Session shall be limited to issues raised by the Request for Exemption filed by SEA-3, Inc., and questions likely to lead to the discovery of evidence or information related to the issues raised in the Request. 3. Procedures. Inquiries shall be in a question form and shall not be argumentative. Repetitive questions or inquiries will not be allowed. Questions and inquires to witnesses should be limited to issues pertaining to the witness's field of expertise, pre-filed testimony, and the scope of the adjudicative proceeding. Questions regarding qualifications of witnesses will also be allowed. If a proper question or inquiry cannot be answered at the time of the Technical Session, the parties will attempt to agree to a date by which the answer must be provided in writing. Said answers are to be distributed to the parties only and shall not be copied to the committee.

4. Counsel for the Committee. Counsel for the Committee will mediate any disputes regarding inquiries and requests for information and will maintain a list of documents or additional answers requested by the parties. To the extent that any party is aggrieved by the handling of any inquiry, question or document request, that party shall file an appropriate motion for discovery, objection to discovery or motion for a protective order. Said motions and/or objections shall be directed to the presiding officer and shall comply with the Committee's Procedural Rules and the pre-trial order issued in this docket.

5. Instructions for Teleconference. If any party requires teleconference services they should contact Counsel for the Committee immediately so that arrangements can be made.
