**AFFIDAVIT OF REBECCA WALKLEY**

I, Rebecca Walkley, being duly sworn, do under oath depose and state as follows:

1. I am an attorney at McLane Middleton, Professional Association, which represents Antrim Wind Energy, LLC (“AWE”) in the above captioned matter.
2. AWE intends to construct and operate a 28.8 MW electrical generating facility consisting of nine Siemens SWT 3.2-113 direct drive wind turbines in Antrim, New Hampshire.
3. RSA 162-H:10, I-c requires that the Site Evaluation Committee hold at least one public hearing in each county in which the proposed facility will be located within 90 days after acceptance of the Applicant’s Application for a Certificate of Site and Facility.
4. By Order dated December 4, 2015 AWE is required to cause a copy of the Notice of Public Hearing for Hillsborough County to be published no later than February 8, 2016, in one or more newspapers having a regular circulation in Hillsborough County. The Site Evaluation Committee further requires that the Applicant provide a copy of the published public notice to the Administrator of the Site Evaluation Committee no later than February 8, 2016.
5. Pursuant to the Statute and the Order, the Public Notice for the Hillsborough County Public Hearing was published in the New Hampshire Union Leader as well as the Monadnock Ledger Transcript on Tuesday, February 2, 2016, which is at least 14 days prior to the session. Copies of the Notice of Public Hearing for Hillsborough County are attached hereto as Exhibit A.

6. As provided in the Notice, a Public Information Session will be held on February 22, 2016 at 6:00 p.m. at the Antrim Town Hall, 66 Main Street, Antrim, NH. The hearing shall be recorded and a moderator will facilitate a question and answer session. Members of the public may also give public comment.
