APPLICATION OF ANTRIM WIND ENERGY, LLC FOR A CERTIFICATE OF SITE AND FACILITY

APPLICANT'S MOTION TO HAVE TECHNICAL SESSION TRANSCRIBED

Antrim Wind Energy, LLC ("AWE" or the "Applicant") by and through its attorneys, McLane Middleton, Professional Association, respectfully moves to have the technical session with witnesses for Intervenors and Counsel for the Public transcribed and to have a transcript of the technical session prepared by a licensed stenographer.

- 1. On July 12 and 13, 2016, the parties will hold a technical session with witnesses for Intervenors and Counsel for the Public.
- 2. The Applicant respectfully moves to have the technical session transcribed and to have a transcript prepared of the session.
- 3. The Applicant will assume the burden of locating and hiring a licensed stenographer and the burden of paying for the costs associated with such services, including the costs of preparing a transcript and a copy for the Committee. The intervening parties would be able to obtain a copy directly from the stenographer at their own expense.
- 4. The Committee has previously granted requests to record and transcribe the technical sessions. *See Order Granting Motion to Record Technical Session*, Docket 2015-05 (April 28, 2016) (stating that "[t]he request to record and transcribe technical sessions is a reasonable request.").

5. Pursuant to N.H. Admin. Rule Site 202.14(d), the undersigned has contacted the parties to this docket in an effort to determine their positions on the motion. The following parties have responded with their positions: John Griffin assents to the Motion, the Harris Center for Conservation Education takes no position on the Motion, and the following parties object to the Motion; Counsel for the Public, the Wind Action Group, New Hampshire Audubon, the Allen/Levesque Intervenor Group, Stoddard Conservation Commission, the Non-Abutting Intervenor Group, and the Abutting Intervenor Group.

WHEREFORE, the Applicant respectfully requests that the Committee:

- A. Grant its request to have the technical session transcribed; and
- B. Grant such further relief as deemed appropriate.
