**MOTION TO EXTEND DEADLINE FOR SUPPLEMENTAL TESTIMONY**

NOW COMES the Town of Antrim, by and through Upton & Hatfield, LLP, and moves to extend the date to file its Supplemental Testimony as follows:

1. Supplemental testimony is due August 15, 2016.
2. Due to the unavailability of counsel for personal reasons,<sup>1</sup> the Town of Antrim requests a 3-day extension to provide supplemental testimony on Thursday August 18, 2016.
3. A 3-day extension “will promote the orderly and efficient conduct of the proceeding and assist in resolving the case fairly” within the meaning of Site 202.17. It will allow the Committee to have the benefit of the views of the Town’s governing body in written form, as contemplated by RSA 162-H:16, IV. It will not impact any other deadline in the procedural schedule.
4. Counsel for the Public, N.H. Audubon, the Stoddard Conservation Commission, Benjamin Pratt, John Griffin, assent to this request. The Stoddard Conservation Commission and Richard & Lorraine Block (non-abutting) stated that they also intended to request an extension to the same date. The Wind Action Group and Janice Longgood oppose this motion. The Applicant and remaining parties had not taken a position as of filing this motion.

WHEREFORE Antrim respectfully requests that the Committee grant this motion and allow the Town of Antrim to file its Supplemental Testimony on August 18, 2016.


