PLEASE TAKE NOTICE that the Site Evaluation Committee will conduct Final Adjudicative Hearings beginning at 9:00 a.m. on October 18, 19 and 20, 2016. The Hearings will be held at <u>49 Donovan Street</u>, <u>Concord</u>, <u>NH</u>.

Introduction

On July 28, 2016, the Presiding Officer issued an Order and Notice of Adjudicative Hearings to be held on multiple days during the month of September. On September 28, 2016, the Presiding Officer issued an Order and Notice of Adjudicative Hearings to be held on October 3, 18, and 20, 2016. This Order and Notice schedules an additional date of October 19, 2016 for the final adjudicative hearings.

Background

On October 2, 2015, Antrim Wind Energy, LLC (Antrim Wind), filed an Application for a Certificate of Site and Facility (Application) with the Site Evaluation Committee (Committee). Antrim Wind proposes to site, construct, and operate 9 Siemens SWT-3.2-113 direct drive wind turbines each capable of generating 3.2 MW for a total nameplate capacity of 28.8 MW and associated civil and electrical infrastructure (Project). The Project is proposed to be located in the Town of Antrim. Antrim Wind seeks the issuance of a Certificate of Site and Facility approving the siting, construction, and operation of the Project.

Final Adjudicative Hearings

On October 18, 19, and 20, 2016, beginning at 9:00 a.m., the Subcommittee will conduct final adjudicative hearings. The hearings will be held at 49 Donovan Street, Concord, NH.

The adjudicative hearing is an evidentiary hearing that is open to the public.

At the conclusion of the evidentiary portion of the proceeding the Subcommittee may deliberate on the merits of whether to grant or deny a Certificate of Site and Facility.

Directions to 49 Donovan Street, Concord, NH

From I-93 North or South, take exit 12N for NH-3A/South Main Street. Merge onto NH-3A-N/South Main Street. Turn left onto Joffre Street and then turn left at the first cross street onto Donovan Street. Follow to the end of Donovan Street and the building will be on your left.
