My name is Michael Pacy and I am the Project Manager for the Eversource / PSNH Southeast Coast Reliability Project (SRP)

The SRP is a new 115kV transmission line project that runs between the Madbury NH substation to the Portsmouth NH substation. The intent is to reinforce the reliability of the power supply in the seacoast region.

The line is about 13 miles long and runs from the Madbury substation though the towns of Madbury, Durham, Newington, Portsmouth and into the Portsmouth substation. Part of the cable runs underwater from Durham under Little Bay and into Newington.

The project route is to be built on the existing right of way along existing power line routes.

Eversource is presently preparing an application to the NH state Site Evaluation Committee (SEC). The SEC evaluates the routing, need, environmental impacts and more to determine if the project is justified and meets state regulations. Eversource has established a schedule to submit the application by the end of the second quarter 2015.

As part of the application Eversource is required to reach out to the several towns and local authorities with public outreach sessions and on site presentations with information on the project for all those concerned.

As part of this process we are making this inquiry to the State Fire Marshall whether he is interested in participating in one of these information sessions or being advised of the project and its scope.
