APPLICANT'S PROJECTED ORDER OF WITNESSES

Pursuant to the Notice of Final Prehearing Conference Agenda and Designation of Hearing Officer, Public Service Company of New Hampshire d/b/a Eversource Energy ("Eversource" or "the Applicant") submits its projected order of witness presentation for the final hearings.
