I. BACKGROUND

provide the estimated amount of time that will be needed for cross-examination of each witness or panel of witnesses. The Intervenor shall also provide the name of the spokesperson for purposes of cross-examination of each of the Applicant's witnesses.

E. Counsel for the Public and Intervenor's Witnesses

1. Counsel for the Public and the Intervenor shall come prepared to discuss the order of witnesses or panel of witnesses that have prefiled testimony in this docket and identify any potential scheduling conflicts. The Applicant, Counsel for the Public and the Intervenor shall provide the estimated amount of time that will be needed for each witness or panel of witnesses.

1. Throughout the proceeding, the parties will be responsible for preparing and updating their final exhibit lists in a table format that contains the discrete designation for each party, the exhibit number, and a brief description of the exhibit.


