Hope all is well with the both of you! I am reaching out to let you know now that the Seacoast Reliability Project is in the restoration phase, we are focusing our efforts back on the cable house. Arnold Graton Associates, Inc. will be mobilizing next week and is expected to have the new foundation constructed and the cable house moved to its new, permanent location by the first week of September 2020. After the structure is moved, we will begin the rehabilitation efforts, which will most likely occur in September and October of this year. Per the SRP MOA, Eversource and our Architectural Historian will consult with the DHR at incremental stages during the rehabilitation plan implementation.

Nadine – if you have availability in the next week or two, it might be a good idea to have a quick call to make sure we are on the same page for the required consultation stages. Please let me know if this is possible.
