**AFFIDAVIT OF BARRY NEEDLEMAN**

I, Barry Needleman, being duly sworn, do under oath depose and state as follows:

1. I am a Director at McLane Middleton, Professional Association, which represents Public Service Company of New Hampshire d/b/a Eversource Energy ("PSNH") and New England Power Company d/b/a National Grid ("NEP") in the above-captioned matter.
2. PSNH and NEP intend to construct a new 345 kilovolt (kV) transmission line, approximately 24-miles long from the Scobie Pond Substation in Londonderry, New Hampshire, to the Substation located in Tewksbury, Massachusetts. The New Hampshire portion of the line will be approximately 18-miles long. In New Hampshire, the proposed facility will be located in the Towns of Londonderry, Hudson, Windham, and Pelham.
3. RSA 162-H:10, I-c requires that the Site Evaluation Committee hold at least one public hearing in each county in which the proposed facility will be located within 90 days after acceptance of the Applicant's Application for a Certificate of Site and Facility.
4. By Order dated November 10, 2015 PSNH and NEP are required to cause a copy of the Notice of Public Hearing for Hillsborough County to be published no later than November 25, 2015, in one or more newspapers having a regular circulation in Hillsborough County. The Order further requires that the Applicants provide a copy of the published public notice to the Administrator of the Site Evaluation Committee no later than November 27, 2015.


5. By Order dated November 10, 2015 PSNH and NEP are required to cause a copy of the Notice of Public Hearing for Rockingham County to be published no later than November 25, 2015, in one or more newspapers having a regular circulation in Rockingham County. The Order further requires that the Applicants provide a copy of the published public notice to the Administrator of the Site Evaluation Committee no later than November 30, 2015.

6. Pursuant to the Order, the Public Notice for the Rockingham County Public Hearing was published in the New Hampshire Union Leader on Monday, November 16, 2015, which is prior to November 25, 2015. Copies of the Notice of Public Hearing for Rockingham County are attached hereto as Exhibit A.

7. The Public Notice for the Hillsborough County Public Hearing was published in the New Hampshire Union Leader on Monday, November 16, 2015, which is prior to November 25, 2015. Copies of the Notice of Public Hearing for Rockingham County are attached hereto as Exhibit B.
