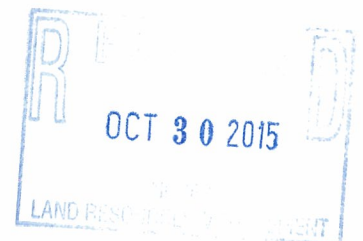
Dear Mr. Drew:

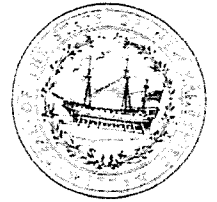

**Northern Pass is a 192-mile transmission line project that will bring 1,090 megawatts (MW) of clean, affordable energy to New Hampshire and to the rest of New England. The project will build a new 158.3 mile long HVDC transmission line from the Canadian border to Franklin, NH. From Franklin, a new 33.7 mile long AC transmission line will carry the energy to an existing substation in Deerfield, NH and into New England's electric grid.**
