## Lis of Sites

1. Haynes Rd. - .3 miles North East of the junction of Haynes and Ridge Rds. (line crosses road)
2. Church St. - .3 miles North West of the junction of Rte.107/North Rd. and Church St. (lines crosses Church St.)
3. Rte. 107 / North Rd - .3 miles NE of Rte 107/North Rd. / Church St. Jct. (where line crosses North Rd. by Lahr's Transmission)
4. Nottingham Rd. - .45 miles from junction of Nottingham and North Rds. (looking Southerly at ridge behind Berglund property)
5. Nottingham Rd. - 1.7 miles SE from junction of Nottingham and North Rds (looking Easterly across pond and wetlands)
6. Nottingham Road - Town Trails
7. Nottingham Road – Proposed rural historic district
8. Cate Rd. - .3 miles from junction of Cate and Nottingham Rds (line crosses Cate Rd.)
9. Actual substation on Cate Rd. with an eye towards envisioning another 4 - 6 acre substation being constructed.
10. Mountain Road
11. Perry Road (Scenic Road) Town trails
12. Meetinghouse Hill Road – peak (Scenic Road)
13. Mt. Delight Road
14. Thurston Pond Road (Pond, Town trail off road – entrance off mail box # 81 Mt. Delight Rd)
15. Pawtuckaway North mountain view of row and power line
16. Deerfield Historic Center – walk the center – many Town events are held in this corridor
  - Deerfield Community Church
  - Sherburne Woods Senior Housing
  - Deerfield Bible Church
  - Deerfield Town Hall and the Gazebo
  - Philbrick-James Library
