Dear Mr. Honigberg and SEC committee,

I am writing to request that your sub-committee immediately reschedule all upcoming Data Request Deadlines. I am copying the Counsel for the Public on this email, as well as the entire Distribution List for SEC Docket 2015-06. I will be sending this email at least three times in succession in order to reach the entire list due to server restraints.

To Date, the *new* Intervener Groupings, announced verbally at the April 12 2016 meeting at Loon Mountain, Lincoln NH have not been issued in writing. Therefore, it is impossible for the accepted Interveners in this matter to proceed in a timely fashion and prepare properly to meet the stipulated deadlines for Data Requests, much less the SEC Counsel, Mr. Iacopino's, recent stricture on communications. It might be noted that many of the Interveners in this matter are ordinary citizens who are Volunteering their time and are often without recourse to expensive Legal Counsel and office staff.

Therefore, I urge the SEC to immediately Order *new* deadlines, appropriately dated from the Actual Issuance of the *new* Grouping Order.
