RE: Technical Session Data Requests

Technical sessions were held on October 26, 27, and 28, 2016, in the above referenced docket. The purpose of the technical sessions is for the parties to inquire of the Applicant's witnesses their expertise, opinions and pre-filed testimony. The parties that were present during all or part of the technical sessions on each day are listed on the sign-in sheets that are attached to this memorandum. Peter Roth, Counsel for the Public, was present each day. Mr. Roth's attorney, Thomas Pappas, was present on October 26 and 28; and his attorney, Eli Emerson was present on October 27.

At the conclusion of the technical sessions, the following data requests to the Applicant remain outstanding:

Oct. 26-Orderly Development—Robert Varney

1. Produce all notes taken by Normandeau staff during meetings with personnel from the four regional planning commissions and professional planners in towns and cities along the project route (if not previously produced in response to a data request).
2. Produce the zoning ordinance summaries and all notes used to prepare the summaries (if not previously produced in response to a data request).
3. Produce any documents or notes that Normandeau maintains that track the updated master plans and revised zoning ordinances that have been adopted since the Northern Pass application was submitted to the SEC.
4. Provide the actual dates that the meetings took place with Normandeau staff and the four regional planning commissions. If this information is included in the application, please state where it is located.
5. Identify the maps of the project that were available in March 2015, that show the height of the towers that would be constructed in Concord.

6. Provide the documents that Mr. Varney reviewed in preparing his report that showed the construction details for the project.
7. Provide the section of the DEIS that formed the basis of Mr. Varney's conclusion that is presented in his pre-filed testimony on Page 5, Lines 18-19.

Oct. 27-Historical Resources—Cherilyn Widell

1. When it becomes available, provide the results of the current field work effort for identifying and assessing the resources associated with the underground portion of the Project.
2. Provide the results of the cultural landscape inventory that was requested by DHR, and is currently being conducted on the Suncook Valley and the Pemigewasset River Valley.
3. Provide the list of, and the individual project area inventory forms for, the 100 properties that are in the overhead portion of the Project route.

Oct. 28-Orderly Development—Lisa Shapiro

1. Provide a copy of the report that Ms. Shapiro completed for the SEC in the Portland Natural Gas Transmission System docket.
2. Provide the project cost estimates that were given to Ms. Shapiro and were used in her report. If this information has been produced in response to a previous data request, provide the Bates number of document.
3. Provide the construction costs that Ms. Shapiro used in calculating the property taxes during the construction period. If this information has been produced in response to a previous data request, provide the Bates number of document.
4. Provide the Preliminary Economic Impacts of Northern Pass report that Ms. Shapiro prepared in the Spring of 2011.

The foregoing shall be provided to all of the parties on or before November 14, 2016. Copies shall not be provided to the Committee. To the extent that the Applicant objects to providing the above referenced material, the requesting party must file a Motion to Compel with the Committee. Any questions regarding this memorandum or the data requests made at the technical session should be directed to Pamela Monroe, Administrator.
