RE: Technical Session Data Requests

A technical session was held on January 19, 2017, in the above referenced docket. The purpose of the technical session is for the parties to inquire of the witnesses for Counsel for the Public and the Intervenors as to their expertise, opinions, and pre-filed testimony. The parties that were present during all or part of the technical session are listed on the sign-in sheet that is attached to this memorandum.

At the conclusion of the technical sessions, the following data requests to the Intervenors remain outstanding:

Jan. 19-IBEW-Joseph Casey and Tiler Eaton

1. Provide the average number of IBEW workers that worked on each of the following projects: Groton Wind; Burgess Biopower; and the Merrimack Station Scrubber.

Jan. 19-Dixville Capital and Balsams Resort-Leslie Otten

1. Provide the analysis, formulas, as well as how the formulas were applied that were provided to Mr. Otten by Dr. William Strauss, and that were used to arrive at the numbers contained in lines 39-40 in Mr. Otten's pre-filed testimony.
2. Provide the analysis, as well as the timeframe for it, that was undertaken to arrive at the \$200,000 estimated savings provided in lines 92-94 of Mr. Otten's pre-filed testimony.
3. Provide the names of all the individuals that provided input to Mr. Otten that formed the basis of the statement referenced in #2, above.
4. Provide any notes or analysis that were used to arrive at the \$30MM number provided in line 109 of Mr. Otten's testimony. In addition, please specify the "region" that is being referred to in that statement.
5. Upon finalization, provide the study that the Balsams is undertaking regarding the existing and future labor force in the North Country.

6. Provide the publicly available information regarding the timing for construction of the Balsams development, as well as information related to discussions with power providers.

Jan. 19-Coos County Business and Employers Group-Allen Bouthillier

1. Provide the minutes of meetings, if any exist, of the CCBEG.
2. Provide any documents that are not in the public domain that are related to the North Country Job Creation Fund.
3. Provide specific contact information for members of the North Country Job Creation Fund.

Jan. 19-SPNHF-Jane Difley

1. Provide any and all information related the SPNHF Policy Committee meetings and its decisions, when it considered its position on the Northern Pass Project as the Project was configured in October 2010, Jun-July 2013, and August 2105.
2. Provide the agenda and minutes of SPNHF Policy Committee meetings where it considered its position on the Northern Pass Project.
3. Provide agendas and minutes for SPNHF Policy Committee meetings where it considered its position on energy projects other than Northern Pass, including: high voltage transmission line; renewable energy; and gas pipeline projects.
4. Provide all communications and reports created by SPNHF regarding proposed energy projects that it considered and the potential effects of those projects on SPNHF resources.
5. Provide a list of donations that were made by energy companies or power generators, and others, that were made for the specific purpose of opposing Northern Pass.
6. Review the SPNHF Forest Resources Plan's stated goals and objectives and provide any instances where the Plan is either consistent or inconsistent with the Northern Pass project.

The foregoing shall be provided to all of the parties on or before February 2, 2017. Copies shall not be provided to the Committee. To the extent that the Intervenor objects to providing the above referenced material, the requesting party must file a Motion to Compel with the Committee.
