Dear Ms. Monroe:

This letter is to inform the committee that the Town of Pembroke, Intervenor in the above-referenced matter, is substituting a witness in opposition of the Applicant's request for a Certificate of Site and Facility, effective as of February 24, 2017.

The Town filed the pre-filed testimony of Justine Courtenmanche, Board of Selectmen for the Town of Pembroke, on November 15, 2016. Due to Ms. Courtenmanche's desire to no longer serve as witness on behalf of the Board of Selectmen, the Town of Pembroke is substituting Town Administrator David Jodoin on behalf of the Board of Selectmen in Ms. Courtenmanche's place. Mr. Jodoin has participated in this matter with the Board of Selectmen and he will be adopting Ms. Courtenmanche's pre-filed testimony and attached report, and in addition, will be responding to the technical session data requests posed to Ms. Courtenmanche.

To provide the appropriate background information, Mr. Jodoin resides at 3 Loon Avenue, Concord NH 03303. He has a Bachelor's Degree in Accounting from Franklin Pierce College. Mr. Jodoin is the Town of Pembroke Town Administrator, Tax Collector, and Finance Director. From 1989 – July of 1994, Mr. Jodoin worked for one of the largest Municipal Accounting firms in the state (Plodzik and Sanderson); from July of 1994 through July of 1996, he then worked for the Town of Allenstown full time as their Administrative Assistant/Finance; he continued to work for Allenstown part time from 1996 through February of 2001 as their Finance Administrator; also from 1996 through February 2001, he was employed full time by the Town of Exeter as their Finance Director. In 2001, Mr. Jodoin returned to Allenstown full time at the Selectboard's request to serve as Finance Administrator. In July of 2005, Mr. Jodoin left Allenstown to become the Town of Hooksett's Town Administrator. He then left Hooksett in December of 2008 to accept the Town Administrator job in Pembroke and has served in that capacity ever since.

Throughout his career, Mr. Jodoin has worked extremely close with the Assessors and has been through four Town revaluations and many yearly statistical


