RE: Technical Session Data Requests

A technical session was held on March 1, 2017, in the above referenced docket. The purpose of the technical session is for the parties to inquire of the witnesses for the Intervenor as to their expertise, opinions, and pre-filed testimony. The parties that were present during all or part of the technical session are listed on the sign-in sheet that is attached to this memorandum.

At the conclusion of the technical session, the following data requests to the Intervenor remain outstanding:

March 1-Combined Group Clarkesville-Stewartstown-Stephan Nix

1. Provide the plans for the properties that abut the ROW that Mr. Nix reviewed on the Coos County Registry of Deeds website.
2. Provide the specific locations where the plans conflict with the boundary alignment.
3. Provide the specific locations where the lines "jog" in the ROW.
4. Provide the specific locations where the plans conflict with existing fences, walls, and structures.
5. Provide the locations where the monuments and cemeteries conflict with the plans as noted on Page 7, Lines 8-15, of the pre-filed testimony.

March 1-Whitefield, Dalton, and Bethlehem Abutters-Peter Powell

6. Provide the project files, if they are available, from the SEC proceeding where Mr. Powell testified on a proposed HVTL in the North Country from approximately 30 years ago.
7. Provide the name and any notes from the conversation that Mr. Powell recently had with a potential buyer from Maine, relating to the property on Route 2 in Lancaster, referenced in Example 5 in Mr. Powell's pre-filed testimony.

March 1-Easton Conservation Commission-Kris Pastoriza

8. Provide the minutes of the ECC meeting where Ms. Pastoriza's pre-filed testimony was reviewed and approved.
9. Provide the name of the engineer that Ms. Pastoriza spoke to regarding the project and any documents that the engineer relied upon in drafting her pre-filed testimony.
10. Provide a copy of the aquifer map for the Town of Easton.
11. Provide all of the DOT meeting minutes that Ms. Pastoriza has in her possession.

March 1-Bethlehem Conservation Commission-Cheryl Jensen

12. Provide all correspondence between the BCC and DES.

The foregoing shall be provided to all of the parties on or before March 13, 2017. Copies shall not be provided to the Committee. To the extent that the Intervenor objects to providing the above referenced material, the requesting party must file a Motion to Compel with the Committee.
