RE: Technical Session Data Requests

A technical session was held on March 2, 2017, in the above referenced docket. The purpose of the technical session is for the Applicant to inquire of the witnesses for Counsel for the Public as to their expertise, opinions, and pre-filed testimony. The parties that were present during all or part of the technical session are listed on the sign-in sheets that are attached to this memorandum.

At the conclusion of the technical session, the following data requests to the Counsel for the Public remain outstanding:

March 2-Counsel for the Public-Samuel Newell and Jurgen Weiss-Brattle Group

1. Provide the basis for the conclusions (work papers) contained in footnote 133, on page 48 and continuing on page 49 of the report.
2. Provide the analysis on the report behind Tables 9 and 10 on page 54.
3. Provide all additional calculations or analysis that completed outside of the excel file workbook that was used to determine capacity market impacts.
4. Provide the workbook that was used for the dynamic delist bid threshold.
5. Provide the PJM data that was used for the core supply shape.
6. Provide a step-by-step description of how the core shape was normalized for the NE market.
7. Provide all notes or e-mail correspondence, if any, relating to Brattle's initial brainstorming session.
8. Provide the MCL used for the Northern NE zone. If it has already been provided in the workbook, then identify where it is.
9. Provide both Mr. Newell and Mr. Weiss' understanding of the meaning of the disclaimer that is on the report.
10. Review the bulleted items on page 37 and provide an opinion as to whether or not the analysis will be revised.

11. Provide an explanation of the changes in the updated report which points to the changes that were made in the excel based model.

The foregoing shall be provided to all of the parties on or before March 13, 2017. Copies shall not be provided to the Committee. To the extent Counsel for the Public objects to providing the above referenced material, the requesting party must file a Motion to Compel with the Committee.
