The purpose of the technical session is for the Applicant to inquire of the witnesses for Counsel for the Public as to their expertise, opinions, and pre-filed testimony. The parties that were present during all or part of the technical session are listed on the sign-in sheets that are attached to this memorandum.

At the conclusion of the technical session, the following data requests to the Counsel for the Public remain outstanding:

From Appalachian Mountain Club (Garland & Kimball)

1. Please provide the list of the buildings, camps, cemeteries, farms, and other historic resources in the supplemental filing from AMC and where they come from.
2. Please provide the "Code Key" from the Section 106 process.
3. Please define meaning of "camp" as specifically referenced at the technical session.
4. Please provide names of the websites and URLs used to determine when a view from a resource was visible with "unaided or naked eye."
5. Please provide the list of 240 resources or identify where in the record they can be found.

From The Society for the Protection of New Hampshire Forests (SPNHF) (Harry Dodson)

1. Please provide a copy of the contract between Mr. Dodson and client (SPNHF).
2. Please provide the work papers relied on in support of the statement on p. 5 of your

testimony that states: "Its overall visual impact is not comparable to any other single infrastructure project existing in the State today."

3. Please provide your work sheets identifying the work to eliminate 36 resources from the 57 evaluated resources.
4. Please provide all files associated with the photo simulations.
5. Please provide the Excel spreadsheet containing all evaluated sites.
6. Please provide the data bases used to identify the 102 scenic resources.
7. Please provide copies of your field notes and field photos (in original format.)
8. To the extent you relied on data from Mr. Garland please provide that data.
9. Please provided all data used to develop the DEM.
10. Please provide the criteria utilized to determine the high, medium or low ranking of effects for extent, nature and duration of use as set forth in the aesthetic evaluation table and the criteria for methodology of determining scope and scale and dominance and prominence ratings in the table. (Appendix D - p. 3.)

The foregoing shall be provided to all of the parties on or before April 3, 2017. Copies shall not be provided to the Committee. To the extent a party objects to providing the above referenced material, the requesting party must file a Motion to Compel with the Committee.
